This has become over burdensome, and she wished to relinquish the trophy responsibilities. Chairman's Report - May 2023

Firstly may I thank all those who have given up their time this year to volunteer and see the Plymouth Badminton League grow. Though the medley divisions was cut to just one, the entries at all the tournaments was up - the dates of the tournaments for next season is already on the website.

I have continued to represent the league on the Devon County Badminton Association committee. I am pleased to let clubs know that my appeal to Badminton England regarding the way that the Devon County Badminton Association carried out their investigations into the allegations against me has been upheld. The Appeals Panel found in my favour by finding that the Devon County Badminton Association had failed to follow the correct procedures and processes across the investigations.

"The Panel unanimously allowed the appeal on the basis that you (Mr Berry) had not been afforded a fair hearing and that there were also disciplinary inadequacies with due process not being followed surrounding the allegations."

Though most of you will be unaware of this but we lost a good friend at Badminton England, Lee Ward; he was someone a number of clubs had turned to for support during and following the pandemic. Badminton England are currently restructuring their workforce with respect to clubs (again) and clubs will be informed of the new structure in due course.

Within the league, most clubs / teams have embraced the electronic spreadsheets. By completing them the league secretaries have been able to keep the division tables up to date with the scores being updated within a day or two. Those "old stagers" who find the new system daunting . . . give a junior player access! Waine and Ryan are putting together a new guide for you all.

Two clubs who put in grant applications to the Devon County Badminton Association have had 50% of each grant agreed by the Devon County Badminton Association committee. The clubs concerned are yet to receive their funding.

So, at this time we should also look forward. Though the league has volunteers running it, we could always do with more. If you do not want to take on a "full" role volunteer to assist with something so you get the opportunity to earn the processes involved.

At the end of the summer break, please talk to your venues re available dates; especially with regard to exam dates. Two clubs, in particular, were hit hard, this past season, and coped very well with the inconvenience. It would be better if communication could improve.

In fact unlike last year, where I was pleading for more people to come and play at tournaments, discussions are now set to take place to determine maximum feasible numbers that can be accommodated at each event. However, I will of course do my best to ensure that all those that wish to play, are eligible to play, and have got their forms in on time are not disappointed.

Thank you to all clubs for promoting tournaments this year, and to the players that have come along and played fairly and respectfully. And to those who brought along raffle prizes to the Christmas tournament. And a final thanks to the Beckley Cup handicapping committee who I call on to help with handicaps for tournaments.

Presentation Evening Report 2023 (Gill Jones)

On Friday 19th May 2023 Plymouth Badminton held their end of season Presentation Evening for 2022-23. For the second year running it was held at the Crownhill Royal British Legion Club (RBLC), Tailyour Road, Crownhill, Plymouth.

The evening commenced at 7pm with just under 80 players attending. Each club were allocated a table(s) with a list of the club's players as well as the basket meals ordered for easy reference. A total of 47 meals had been ordered. The RBLC would have preferred to have had the basket meals paid for in advance but they did agree to allow for individual payments to be made on the night as players collected their meals. This did put extra pressure on the kitchen staff but they did manage to get all the meals served between 7:30-8:30 so thanks go to the staff.

I would like to thank the 2 Tavyside players who once again stepped up to sell / promote the raffle tickets. They did a fantastic job selling a total of 620 draw tickets worth £124. As society moves towards a cashless one it was notable that some players were unable to buy any tickets as they carried no money.

Of the feedback received already, suggestion has been made that the evening lacked a degree of atmosphere and that perhaps the option of having a disco in the future might merit discussion. It was agreed at the AGM that this would be discussed in the autumn.

On a final note, it was good to see such a large turnout from Kuasa.
